RESOLUTION NO. 98-42
of the
SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and,

WHEREAS, under the Constitution and Bylaws of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, and general welfare of the Squaxin Island Tribal Reservation residents; and,

WHEREAS, Section 102 (c) (5) of NAHASDA requires that a "Certification of Compliance" be submitted with an Indian Housing Plan.

THEREFORE BE IT RESOLVED that the Squaxin Island Tribal Council does hereby provide the following evidence of compliance as an attachment to the Tribe's Fiscal Year 1998 Indian Housing Plan:

Native American Housing Assistance and Self-Determination Act

Indian Housing Plan
Standard Certification of Compliance

This certification is for use with the Indian Housing Plan (IHP). If the IHP is prepared and submitted by a Tribally Designated Housing Entity on behalf of a tribe, it must be accompanied by a tribal certification from a recognized tribal government covered under the IHP.

In accordance with the applicable statutes, the recipient certifies that:

(A) the Tribe's TDHE, the South Puget Sound Inter-Tribal Housing Authority, will comply with title II of the Civil Rights Act of 1968 in carrying out this Act, to the extent that such title is applicable, and other applicable Federal statutes;

The following certifications will only apply where applicable based on program activities relative to insurance coverage and policies of the Tribe's TDHE:


- (B) the TDHE will maintain adequate insurance coverage for housing units that are owned and operated or assisted with grant amounts provided under the Native American Housing and Self-Determination Act of 1996, (the Act), in compliance with such requirements as may be established by the Secretary;

- (C) policies are in effect and are available for review by the Secretary and the public governing the eligibility, admission, and occupancy of families for housing assisted with grant amounts provided under the Act;
- (D) policies are in effect and are available for review by the Secretary and the public governing rents charged, including the methods by which such rents or homebuyer payments are determined, for housing assisted with grant amounts provided under the Act; and
- (E) policies are in effect and are available for review by the Secretary and the public governing the management and maintenance of housing assisted with grant amounts provided under the Act.
