



# SQUAXIN ISLAND TRIBE

**RESOLUTION NO. 98-68**  
**of the**  
**SQUAXIN ISLAND TRIBAL COUNCIL**

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

**WHEREAS**, under the Constitution and Bylaws of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, and general welfare of the Squaxin Island Tribal Reservation residents; and,

**WHEREAS**, under the Constitution and Bylaws of the Tribe, the Squaxin Island Tribal Council has the powers and duties to acquire, manage, or lease Tribal real property and other Tribal assets; and,

**WHEREAS**, the Squaxin Island Tribal Council has the general goal of making the Squaxin Island Reservation an economic, social, cultural, and political land base for the Squaxin Island Tribe; and,

**WHEREAS**, the Squaxin Island Tribal Council on behalf of the Tribe has purchased a parcel of property adjacent to a Tribal housing area which has been proclaimed reservation; and,

**WHEREAS**, the said parcel is of prime importance for the future cultural and economic development of the Squaxin Island Tribe, and will be developed as part of the Cultural, Social Services, and Administrative complex; and,

**WHEREAS**, the Squaxin Island Tribal Council has determined that Tribal real property can best be managed and protected if it is owned by the United States in trust for the Tribe.


**NOW THEREFORE BE IT RESOLVED**, the Squaxin Island Tribal Council does hereby request that the United States, pursuant to 25 CFR 151 and under the authority of the Indian Reorganization Act 48 Stat. 984, accept title to the following described real property in trust for the Squaxin Island Tribe:


