## RESOLUTION NO. 98-<u>98</u> of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1865; and,

WHEREAS, under the Constitution and By-laws of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, and general welfare of the Squaxin Island Tribal Reservation residents; and,

WHEREAS, the budget ordinance calls for the establishment of a Budget Authority which identifies all expected revenues anticipated to be received from all sources, and that the Budget Authority be approved by the Tribal Council, and

WHEREAS, the Comptroller has prepared the Budget Authority documents attached, and has recommended to the Tribal Council that this be the initial Budget Authority for planning purposes,

**NOW THEREFORE, BE IT RESOLVED**, that the Squaxin Island Tribal Council does hereby approve the Fiscal Year 1999 Budget Authority in the initial amount of  $\$\mathcal{E}, 969, 313$ , as attached.
