RESOLUTION NO. 23-56

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources and rights of the Tribe; and

WHEREAS, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, the Tribe has entered into a Memorandum of Understanding (MOU) with the City of Tumwater, dated April 4, 2023; and

WHEREAS, the purpose of the MOU is to reflect the commitment of the parties to honor their government-to-government relationship, improve communications and mutual understanding, and implement a forum to discuss, review and recommend procedures to strengthen their government-to-government relationship; and

WHEREAS, in order to effectively implement the MOU, the parties have agreed to the creation of an Intergovernmental Committee, which will be comprised of two official representatives from each of the parties;

THEREFORE, BE IT RESOLVED, the Tribal Council hereby designates and appoints Tribal Council Member no. 1, Jeremie Walls and Tribal Council Member no. 2, Vicki Kruger, to the Intergovernmental Committee, as representatives of the Squaxin Island Tribe.

CERTIFICATION

The Squaxin Island Tribal Council hereby certifies that the foregoing Resolution was adopted at the regular meeting of the Squaxin Island Tribal Council, held on this 14th day of September, 2023, at which time a quorum was present and was passed by a vote of 6 for and 0 against, with 0 abstentions.
