RESOLUTION NO. 23-69

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources and rights of the Tribe; and

WHEREAS, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, the Squaxin Island Tribal Council finds that regulation of Title 9, Law and Order Code is essential to the health and welfare of the Squaxin Island Tribe and its members; and

WHEREAS, section 9.12.1050 of the Squaxin Island Tribal Code conflicts with the set schedule of the Squaxin Island Court; and

WHEREAS, the Squaxin Island Court wishes to amend section 9.12.1050 of the Tribal Code.

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby adopts the following amendment to Title 9, Law and Order Code:

9.12.1050 – Hearing – Service – Time.


Upon receipt of the petition, the Court shall order a hearing, which will be held not later than ~~twenty (20)~~ thirty (30) days from the date of the order. Personal service shall be made upon the respondent not less than seven court days prior to the hearing. If timely service cannot be made, the Court may set a new hearing date.
