## RESOLUTION NO. 24- 04

of the

### SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**

**WHEREAS**, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**

**WHEREAS**, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**

**WHEREAS**, the US Department of Health and Human Services (DHHS) Indian Health Service has announced the availability of new funding through its Community Opioid Intervention Prevention Program to address the opioid crisis through education, prevention, treatment, recovery services, and harm reduction; **and**

**WHEREAS**, the Squaxin Island Tribe administers through its Health Services Department a variety of prevention and primary care services that support wellness and health; **and**

**WHEREAS**, the Squaxin Island Tribe has identified the need to support prevention, early identification for opioid use concerns, and intervention, treatment, recovery support, and harm reduction for appropriate patients;

**NOW THEREFORE BE IT RESOLVED**, that the Squaxin Island Tribal Council does hereby authorize the Health Services Department to prepare, submit, negotiate, execute, and administer with the DHHS Indian Health Services a five-year project through the Community Opioid Intervention Prevention Program for up to \$500,000 per year with no match requirement;

**BE IT FURTHER RESOLVED**, that the Squaxin Island Tribal Council does hereby authorize the Tribal Chair, Executive Director, and the Director of Operations to be the Tribe's signatories and representatives in all future matters requiring Tribal authorization on this particular project; **and**

**THEREFORE BE IT FINALLY RESOLVED**, that these authorities shall be for the duration of the project.

### **CERTIFICATION**
