



# SQUAXIN ISLAND TRIBE

## RESOLUTION NO. 24-17

of the

### SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

**WHEREAS**, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources and rights of the Tribe; and

**WHEREAS**, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

**WHEREAS**, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

**WHEREAS**, Squaxin Island Emergency Management is responsible for the overall incident management of emergencies and major disasters; and

**WHEREAS**, Emergency Management is charged with drafting and adopting a Comprehensive Emergency Management Plan (CEMP), which establishes the center role of the Emergency Operations Center (EOC) in overall incident management and provides a method to address the Tribe's preparedness for handling and responding to disaster and emergencies, and assisting citizens to be prepared in case of disasters and emergencies; and

**WHEREAS**, the completion of the CEMP was a collaborative effort by Emergency Management, tribal departments, tribal enterprises, private non-profits and local first responders, each with their own primary roles and responsibilities in responding to emergencies and major disasters;

**NOW THEREFORE BE IT RESOLVED**, Emergency Management wishes to submit the attached CEMP for Squaxin Island Tribal Council approval and formal adoption;

**FINALLY, THEREFORE BE IT RESOLVED**, the 2023 CEMP is hereby promulgated and adopted by the Squaxin Island Tribal Council. This 2023 CEMP supersedes all previous CEMPs and shall be effective immediately;

**NOW, THEREFORE BE IT FURTHER RESOLVED**, that the Tribal Council recognizes that the CEMP is a living document in a near constant state of review. The CEMP shall be reviewed and updated at minimum every 5 years. Any changes to the CEMP shall be presented to the Tribal Council for final approval.

### CERTIFICATION

The Squaxin Island Tribal Council hereby certifies that the foregoing Resolution was adopted at the regular meeting of the Squaxin Island Tribal Council, held on this 22nd day of February, 2024, at which time a quorum was present and was passed by a vote of 6 for and 0 against, with 0 abstentions.
