RESOLUTION NO. 24-27 of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources and rights of the Tribe; and

WHEREAS, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, Homeland Security Region 3 Mutual Aid Agreement for Emergency Response and Recovery

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, for the protection of people and preservation of property, utilizing mutual aid agreements promotes an effective and efficient response through rapid resource acquisition; and

WHEREAS, signing the Homeland Security Region 3 Mutual Aid Agreement, Squaxin Island Tribe may request assistance from nearby counties, fire districts, and cities within Homeland Security Region 3,

NOW THEREFORE BE IT RESOLVED, in order to provide an effective and efficient response Squaxin Island Tribe will join the Homeland Security Region 3 Mutual Aid Agreement outlining operational conditions which allows the Tribe to request resources from other counties, fire districts, and cities within Region 3.

CERTIFICATION
