RESOLUTION NO. 24-47

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**

WHEREAS, The Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self government;

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**

WHEREAS, the Squaxin Island Tribal Council authorizes the Bureau of Indian Affairs (BIA), Northwest Regional Offices (NWRO), to allocate Pacific Salmon Treaty (PST) funds for the Fiscal Year 2024(FY24), to the Squaxin Island Tribe's Coho smolt research and data- gathering projects in South Puget Sound.

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council adopts the recommended FY24 PST Proposal for funds and the FY23 PST Progress Report presented in the attached documents submitted by Daniel Kuntz, Natural Resources Program and Policy Manager, of the Squaxin Island Tribe.
